

I BIP/DVA Volleyball Management Player Representation Agreement

I _____ am hereby selecting, Bring It Promotions LLC (BIP) and Diamar Volleyball Agency (DVA) to promote and represent me, as a volleyball player and I understand the following:

I currently have no existing, nor can I make new written or verbal contracts, with any other player-agent, agency, scout, or representative. I hereby appoint BIP/DVA Volleyball Management, exclusive representation rights and responsibility of serving as an intermediary for all elements of my professional volleyball career. I agree that the aforementioned exclusive representation rights and responsibilities bestowed to BIP/DVA volleyball management include, but are not limited to, all contract procurement, negotiation, and construction within all federations and all teams anywhere worldwide. I agree that the aforementioned exclusive representation rights are effective immediately and apply indefinitely or until formal written termination notice is submitted directly to BIP/DVA volleyball management in which case I am subject to all terms in the termination agreement.^β

II TERMS OF AGREEMENT

BIP/DVA assure their best effort and application of necessary resources to discover opportunities and construct contracts respective of my specifications and personal needs. BIP/DVA agree to conduct all team negotiations in a transparent manner, in direct coordination with the respective player, and in the best interest of the player.

III FINANCIAL COMPENSATION

I have exclusive discretion to the final signing of contracts that confirm salary and bonus payments. With the exception of the employing club, I will always be the sole signer of contract agreements.

With regard to matters of finance or other management issues, I hereby assure that I will immediately refer any attempted contact made by prospective teams, managers, or coaches to BIP/DVA for the purpose of negotiating contractual terms in my best interest.

BIP/DVA Volleyball Management

As compensation for all of the above-mentioned management services, the club will directly compensate BIP/DVA with a *maximum* fee of 10% the total agreed upon contractual compensation (excluding bonuses).

Payments to BIP/DVA will be made exclusively from the respective club, after the contract has been finalized, and before the release of my FIVB transfer certificate. I agree to support BIP/DVA in the acquisition of this fee for the above stated management services.

^β The termination of this contract is effective the first (1) of March following the submission of a termination notice (TN). The TN is to be submitted in writing, sent directly to BIP/DVA by certified mail and must be accompanied by a processing fee of 3000 euro to be directly paid to BIP/DVA. In the case that I, the player, choose to remain additional seasons with the same club on which I was originally placed by BIP/DVA, I hereby affirm that BIP/DVA retain full rights to all agency-resigning fees paid by the club in question.

I understand that a paid FIVB Transfer is required for all foreign contracts and ask that my national federation does not release my FIVB transfer without written consent from BIP/DVA. I understand that if I agree to reside with a club where BIP/DVA have made the initial placement, the club must pay BIP/DVA a *maximum* fee of 10% the total agreed upon contractual compensation of each subsequent resign or contract revision.

If the case arises where a club has not paid me on time, BIP/DVA will take upon the responsibility of legally obliging the club to adhere to their contractual obligations. I understand that I need to notify BIP/DVA within one week of any late or partial payment.

IV RIGHTS & RESTRICTIONS

I hereby understand that while under contract with a club, any player recommendations to fill positions in that club or any other club for the remainder of the current season or for the following season must be conducted through BIP/DVA.

I give BIP/DVA the right to use my name and image in promotional materials for BIP/DVA related tournaments, tours, foreign club teams, and all BIP/DVA sponsored events.

I understand that all contractual obligations may be terminated if I do not responsibly offer my services as a professional volleyball player. I understand that I have a contractual obligation to initially arrive in suitable athletic condition and I am responsible for maintaining a reasonable athletic way of living.

I am obligated to observe regulations pertaining to my respective club, the national league, the national federation, the FIVB, and the civil regulations within the country where I am playing. I understand that I must also abide by club, legal, and official authority in regards to disciplinary matters and substance testing.

Upon signing below, I acknowledge that I have read and understand all terms, conditions, and responsibilities listed in the above "Player Representation Agreement".
