

Player Representation Agreement

I, _____ am hereby selecting Bring It Promotions, LLC (BIP LLC) (Tim Kelly, Cory Solomon, Nick Ptaschinski, Steven Fenosik and all related foreign and domestic agents) to promote and represent me as a volleyball player and understand the following:

- I can have no written or verbal contracts with any other player agent, scout, or representative for the period ending October 31, 2012.
- If other player agents, scouts, coaches or team representatives have verbal contact with me or written contact (e.g. Facebook, e-mail), I will notify BIP immediately.
- For me to play under any professional indoor volleyball contract, it must be procured and negotiated by BIP.
- I give Kostas MARGARITIS/Diamar Agency sole right of representation for me in Greece for all contract procurement and negotiation for the duration of my PRA with BIP.
- I give Annarita SENSINI/SEGIT Management sole right of representation for me in Italy for all contract procurement and negotiation for the duration of my PRA with BIP.
- If I am placed in the 2012-2013 season, my contract with BIP automatically extends until October 31, 2013.
- If I am a member of the USA National Team at the time of placement, I understand that the team will have to pay a 10% transfer fee to the USAV for my release. I understand that I will not receive any money from this transfer payment. 5% will stay with the USAV and 5%* will be paid to BIP.
- If I am not a member of the USA National Team, I will pay a fee of 5% of the contract value. This fee will be paid within 15 days of the season's end. The 5% is calculated on base salary, not bonuses, and only paid to BIP after I've received all of my salary.
- All transfer and team management fees must be paid to BIP and/or USAV before my International Transfer Documents are released from USAV and before I play in a match with any team.
- I ask that the USAV (USA Federation) does not release my FIVB papers without expressed consent from BIP for the duration of my agreement with BIP.
- In some cases, the team will be charged a fee by BIP LLC. The team fee due to BIP is an annual fee. Teams extending future contracts to me will have to pay the fee prior to each season, regardless of whether or not I continue to work with BIP.

- I give BIP the right to use my name and image in promotional materials for BIP and related tournaments, tours, foreign club teams, and all BIP sponsored events.
- If the team on which BIP places me needs additional players for the season, I will inform BIP of the team's need for players. I understand that BIP strives to maintain loyalty and good communication with all players with the hope that players value our efforts and services to the extent of recommending our agency to friends, old teammates, and coaches.
